AN ORDINANCE AMENDING ORDINANCE 748 FOR THE RECONNECTION FEE OF WATER SERVICES AFTER WATER SERVICES HAVE BEEN SHUT OFF FOR NONPAYMENT OF WATER BILL

VILLAGE OF KINCAID, CHRISTIAN COUNTY, ILLINOIS

WHEREAS, the President and Village Board of Trustees of the Village of Kincaid believe it is in the best interests of the public health, safety, morals, and welfare of the residents of the Village of Kincaid and those who enter the territorial jurisdiction of the Village of Kincaid to charge a reconnection fee for water services after water services have been shut 'off for nonpayment of water bills.

NOW THEREFORE, BE IT ORDAINED by the President and Village Board of Trustees of the Village of Kincaid, Christian County, Illinois as follows:

SECTION 1: The disconnection fee of water services after non-payment of water bill shall be Fifty Dollars (\$50.00). The reconnection fee of water services after balance has been paid in full shall be Fifty Dollars (\$50.00).

SECTION 2: The provisions of other Village of Kincaid Ordinances, to the extent that they duplicate, conflict with, or otherwise affect the validity hereof, shall be disregarded, and otherwise, all of the provisions of all other Village of Kincaid Ordinances shall remain in full force and effect.

SECTION 3: If any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision, or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.


SECTION 4: This Ordinance shall become effective upon its passage, approval, adoption, and publication in pamphlet form as provided by law.
