AN ORDINANCE AMEDING ORDINANCE NO. 869, PARAGRAPH
(H) ALLOWING ATV'S TO BE OPERATED ON ANY STREETS OR

VILLAGE OF KINCAID UPON WHICH THE VILLAGE OF
KINCAID HAS JURISDICTION

WHEREAS, the President and the Village of Kincaid Board of Trustees, believe it is in the best interest of the public health, safety, morals, and welfare of the residents of the Village of Kincaid and those people who enter the territorial jurisdiction of the Village of Kincaid to not allow the operation of ATVs within the corporate limits of the Village of Kincaid.

NOW THEREFORE, BE IT HEREBY ORDAINED by the President and the Village Board of Trustees of the Village of Kincaid, Christian County, Illinois, as follows:

SECTION 1: Section (H) of Ordinance No. 869 shall be deleted in its entirety and replaced with the following:

H. In addition to golf carts, side by sides shall be allowed to be operated on any streets or roadways within the corporate boundaries of the Village of Kincaid upon which the Village of Kincaid has jurisdiction.

The rules governing golf carts used in Kincaid shall equally apply to side by sides. Furthermore, the required equipment for golf carts shall equally apply to side by sides. Finally, side by sides shall also be subject to the same permits needed as golf carts along with all requirements as otherwise set forth in Ordinance No. 869, as amended.

SECTION 2: The provisions of other Village of Kincaid Ordinances, to the extent they duplicate, conflict with, or otherwise affect the validity hereof, shall be disregarded, and otherwise, all of the provisions of all other Village of Kincaid Ordinances shall remain in full force and effect.

SECTION 3: If any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such holdings shall not affect or otherwise impair any other section, clause, provision, or portion of this Ordinance which is not, *in* or *of* itself, invalid or unconstitutional.

<u>SECTION 4:</u> This Ordinance shall become effective upon its passage, approval, adoption, and publication in pamphlet form as provided by law.
